CITY COUNCIL MEETINGS

The meeting notice and agenda is posted at least 48 hours before the meeting and posted at City Hall, Post Office, Rosebud County Courthouse. All meetings are open to the public.

PUBLIC NOTICE OF CODE CHANGES

There have been significant changes made to the municipal code for the City of Forsyth. These changes will be effective beginning January 1st, 2019. Copies of the changes are available at the following locations: City Hall, Rosebud County Library and on the Forsyth Chamber website (forsythmt.com). The entire code book is available for viewing at City Hall.

SNOW AND ICE REMOVAL

It shall be the duty of the owner or tenant of any premises a butting or adjoining any public sidewalk to remove all snow and ice from such sidewalk, or as much thereof as may be reasonably be removed to make the same passable for public pedestrian traffic, as soon after the accumulation of such ice or snow as my be reasonably be done, and in any event no longer than forty eight (48) hours after the accumulation of such ice and snow. (Code: 8-3-1-A)

BUSINESS LICENSES

All licenses shall be payable in advance on or before January 31 of each year and all licenses shall expire on December 31 of the year of issuance. (Code: 4-1-4)
